**STATEMENT BY SUPERVISOR JEFFREY C. MCKAY**

The announcement of the largest fraud investigation in Fairfax County's history is great news for our citizens.

This investigation started right here in Lee District when neighbors called my office with concerns that appeared completely out of character with the neighborhood. Subsequent strike team and police investigations uncovered evidence extensive enough to call in the FBI and as we heard today, there is evidence of mortgage fraud in excess of \$100 million dollars involving hundreds of houses throughout the County.

This proves the value of alert and engaged neighborhoods that care about their community. It also illustrates the professionalism of the many different County organizations that worked as a team to bring this investigation to fruition.

It's easy to think of mortgage fraud as just another faceless financial crime. Ask anyone in a community that has been affected and you'll hear about the toll it takes on their

neighborhood. I am proud of our community and our County agencies, police, and FBI who have all worked together to slam the brakes on this crime against neighborhoods.

I would like to thank my Lee District neighbors for their perseverance. We know our neighborhoods and we know when something is not right.

And I say to those who would break our laws—you've picked the wrong County. In this County, we work together to protect our community and our citizens and we stop at nothing to ensure that justice is served.



The police issued the following press release on this event:

**POLICE BUST MAJOR MORTGAGE SCHEME**

The Fairfax County Police Department, in conjunction with the FBI, has arrested 20 suspects involved in an elaborate fraudulent mortgage operation. One team leader and 15 detectives and agents have been investigating the alleged complaint since November of 2007 when local elected officials contacted the Major Crimes Division of the Criminal Investigation Bureau. The officials received several complaints from constituents regarding small houses being torn down then built into mansions to be used as boarding houses.

The investigation led police on a countywide search through zoning records and permits involving over 200 houses. Many of the permits were issued under the same name. The buyers of the homes allegedly signed fraudulent documents. "Straw buyers," with annual incomes of less than \$25,000, were being approved for loans over \$600,000.

Several of the arrested subjects were part of a criminal enterprise. They were acting in the

capacity of real estate agents, mortgage brokers, and subcontractors. “Straw buyers” were approached and compensated for the use of their unflawed, personal information. The suspects used numerous bank accounts to “float” money into the “straw buyers” accounts so they could qualify for large loan amounts. The house was purchased, torn down, and rebuilt into a mansion sold to a second “straw buyer” for twice the original amount. The house was bought and sold several more times between a network of “straw buyers,” each at higher prices.

Phase I of the investigation ended with arrests relating to 35 houses, valued at \$20 million. Over 200 properties may be involved and the estimated real estate value of the remaining homes is over \$100 million. The majority of the homes were located in the Springfield, Falls Church, Vienna, Annandale, and Alexandria areas of the county.

The FBI joined the investigation in the fall of 2008. Schemes such as the one dismantled today are complex and require a significant amount of resources, far more than any one law enforcement agency can provide. The Fairfax County Police Department partnered with members of the Real Estate Fraud Investigations Task Force in the investigation of this scheme.

The FBI funds 16 such mortgage fraud task forces across the country for the sole purpose of disrupting and dismantling significant criminal enterprises committing mortgage fraud. The real-time collaboration required in this case involved task force members from federal, state, and local law enforcement agencies, the United States Attorney’s Office and the Common-

wealth Attorney’s Office in Fairfax County.

Seventeen teams of over 100 detectives and agents arrested 20 suspects on Thursday, September 24. The crimes in the arrest warrants include conspiracy to commit wire and mail fraud, using false statements to obtain property or credit, wire fraud, and mail fraud. Convicted suspects of the federal charges could face up to 30 years in prison and fines of up to \$1 million.

Fairfax County Police would like to thank the Washington Field Office of the FBI, the United States Attorney’s Office, the Fairfax County Code Enforcement Strike Team, Fairfax County Sheriff’s Office, Virginia Department of Taxation, Fairfax County Commonwealth Attorney’s Office, Immigration and Customs Enforcement (ICE), the United States Postal Service and the Financial Crimes Enforcement Network (FinCEN).

Out of 2400 homes within our geographical boundaries, only 513 homes remain for receiving the Handbook. This is really great considering that the Handbook has been delivered door-to-door! The Handbook has not

been delivered to homes on the following streets: Ashley, Augusta, Backlick, Byron, Camberly, Clearbrook, Danbury, Dorchester, Edgebrook, Edgerton, Falmouth, Gary, Gilbert, Greenville, Halifax, Hallmark, Hastings, Howe, Inverness, Julian, Lauralin, Mendota, Middlesex, Monticello, and Old Keene Mill. If you live on any of these streets, please consider volunteering an hour of your time to get out and meet your neighbors while delivering the Handbook.

We would prefer to deliver the Community Handbook to the remaining homes in person. **Please note** that the Handbooks were moved from the Lake Accotink Park office, so if you can help deliver Handbooks, please contact me at 202-276-4786 or via email at [lgonzalez@kpmg.com](mailto:lgonzalez@kpmg.com) to pick up some Handbooks. JEWELRY THEFTS INCREASE

Fairfax County Police have seen an increase in jewelry thefts in the Sully, Reston, and Fair Oaks Districts over the last few months. Overall burglaries in those areas have dropped by 21%; however, the increase is found in the type of property being stolen, particularly jewelry. Detectives are attributing these thefts to the recent increase in value of all precious metals, including gold, silver, and platinum. Below are some tips to keep your gems safe:

- Always call police if you see people going door to door acting suspiciously
- Keep all valuables out of sight
- Keep jewelry in a secure location
- Keep items made of precious metals secure
- Be mindful when discussing your valuables
- Document valuables with photos and serial numbers
- Always keep home and business entryways locked
- Always be aware of your surroundings

There was a 55% increase in burglaries involving stolen jewelry in those districts over the last year. 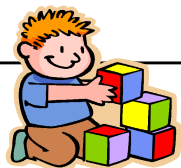

The next seminar is scheduled at the Franconia District Station, located at 6121 Franconia Road, from 8:00 a.m. to 4:00 p.m. on **November 14, 2009**. A MESSAGE FROM SUPERVISOR JEFF MCKAY

**NO ROOM IN LEE DISTRICT FOR  
MORTGAGE FRAUD AND BOARDING HOUSES**

**T**hursday, September 24, marked a huge victory for the residents of Lee District and Fairfax County. What began years ago right here in Lee District resulted in the largest fraud investigation in the history of Fairfax County! Astute citizens, my office, multiple county departments, the police, the FBI and other law enforcement agencies have been working behind the scenes for two years to research, find, and now arrest perpetrators of mortgage fraud and illegal boarding houses throughout this county. Keeping silent during the two years of this criminal investigation was politically difficult but it was worth it not to undermine the case.

There's been no lack of community concern and anger, and tempers—including mine—have flared over the proliferation of illegal boarding McMansions in our communities. While I sought and achieved widespread operational changes in our zoning enforcement and Strike Team operations, zoning enforcement challenges still remained, leaving a sour taste in the mouths of communities. While operationally we are now better off, it was critical that we seek criminal prosecution of those who engaged in mortgage fraud to create hundreds of boarding houses. While we needed zoning enforcement to take place, criminally prosecuting mortgage fraud was key, and I insisted that both occur simultaneously. That's important because mortgage fraud isn't just another faceless financial crime. Ask anyone in a community that has been affected, and you'll hear about the toll it takes on their neighborhood. I am proud of our community and our County agencies,



police, and FBI who have all worked together to slam the brakes on this crime against neighborhoods.

What does all this mean? It means that citizens—who know their communities and know when something is not right—can change the face of government. Democracy is alive and well in Lee District and to my constituents I say, I heard your concerns, I agreed with your concerns, and what may have sometimes seemed minor has turned into a vast collection of fraudulent actions involving a potential loss of over \$100 million to mortgage lenders. We have devoted enormous county resources to this effort because we care about our citizens and we will protect our neighborhoods.

In Lee District, and in Fairfax County, the message is clear: If you run an illegal boarding house and are engaged in mortgage fraud, we will find you, we will prosecute you, and justice will be served. I thank those communities who have been under assault by frauds running boarding houses for their patience. I always said we would win this battle, protect our neighborhoods, and regain faith in the County's ability to fight for our citizens.

### **District-Wide Community Parking District Approved in Lee District**

In January 2009, I asked for community input about creating a district-wide community parking district (CPD) that would cover all of Lee District and prohibit the parking of boats and RVs on residential streets. A CPD would increase pedestrian and traffic safety and save communities from the cumbersome and lengthy petition process that was required to

create a parking district. Since that January meeting, I have spoken with many Lee communities and citizens about this proposal and asked about it on my Lee District questionnaire. Community input has been overwhelmingly in favor of this.

On October 19, the Board of Supervisors held a public hearing on a Lee District CPD. Following testimony, letters, and emails from Lee District residents, the Board of Supervisors unanimously approved creating the CPD.

#### **What Residents Need to Know**

The Lee District large area CPD will go into effect on November 18. For the next month (until December 18,) Fairfax County Police will place warning notices on any boats or RVs parked on residential streets. From December 18 on, the police will issue 48-hour warnings to move the illegally parked vehicles. Should a vehicle not be moved, the police will issue a parking ticket and the vehicle will be towed 48 hours after the ticket is issued.

This CPD does not prevent residents from parking their boats and RVs in their driveways or at storage facilities. For more detailed information about the new CPD, please call Joan Clark in my office (703-971-6262) or email [joan.clark@fairfaxcounty.gov](mailto:joan.clark@fairfaxcounty.gov).

I thank all who shared their opinions on parking restrictions with me through this process. This new parking restriction will help to make our neighborhoods safer.

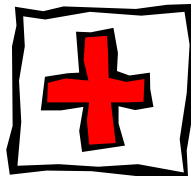
