The Springfield Swim and Racquet Club is in the process of approval for a cell phone tower (mono-pole) to be erected on their property. Rental income from this structure would aid the organization financially. Several of you have contacted me asking for more information. This specific issue will be part of the Board of Zoning and Appeals hearing on March 24. A representative of the club may be at our March 16 meeting and you can get more of your questions answered. The tower will be constructed to resemble a tree. The following information below is from the FCC on the health concerns regarding cell phone towers:

## Human Exposure To Radio Frequency Fields: Guidelines For Cellular & PCS Sites

## FCC Consumer Facts

### Background

Primary antennas for transmitting wireless telephone service, including cellular and Personal Communications Service (PCS), are usually located outdoors on towers, water tanks, and other elevated structures like rooftops and sides of buildings. The combination of antenna towers and associated electronic equipment is referred to as a "cellular or PCS cell site" or "base station." Cellular or PCS cell site towers are typically 50-200 feet high. Antennas are usually arranged in groups of three, with one antenna in each group used to transmit signals to mobile units, and the other two antennas used to receive signals from mobile units.

At a cell site, the total radio frequency (RF) power that can be transmitted from each transmitting antenna depends on the number of radio channels (transmitters) that have been authorized by the Federal Communications Commission (FCC) and the power of each transmitter. Although the FCC permits an effective radiated power (ERP) of up to 500 watts per channel (depending on the tower height), the majority of cellular or PCS cell sites in urban and suburban areas operate at an ERP of 100 watts per channel or less.

An ERP of 100 watts corresponds to an actual radiated power of 5-10 watts, depending on the type of antenna used. In urban areas, cell sites commonly emit an ERP of 10 watts per channel or less. For PCS cell sites, even lower ERPs are typical. As with all forms of electromagnetic energy, the power density from a cellular or PCS transmitter rapidly decreases as distance from the antenna increases.

Consequently, normal ground-level exposure is much less than the exposure that might be encountered if one were very close to the antenna and in its main transmitted beam. Measurements made near typical cellular and PCS cell sites have shown that ground-level power densities are well below the exposure limits recommended by RF/microwave safety standards used by the FCC.

### Guidelines

In 1996, the FCC adopted updated guidelines for evaluating human exposure to RF fields from fixed transmitting antennas such as those used for cellular and PCS cell sites. The FCC's guidelines are identical to those recommended by the National Council on Radiation Protection and Measurements (NCRP), a non-profit corporation chartered by Congress to develop information and recommendations concerning radiation protection. The FCC's guidelines also resemble the 1992 guidelines recommended by the Institute of Electrical and Electronics Engineers (IEEE), a non-profit technical and professional engineering society, and endorsed by the American National Standards Institute (ANSI), a non-profit, privately-

funded, membership organization that coordinates development of voluntary national standards in the United States.

In the case of cellular and PCS cell site transmitters, the FCC's RF exposure guidelines recommend a maximum permissible exposure level to the general public of approximately 580 microwatts per square centimeter. This limit is many times greater than RF levels typically found near the base of cellular or PCS cell site towers or in the vicinity of other, lower-powered cell site transmitters.

Calculations corresponding to a "worst-case" situation (all transmitters operating simultaneously and continuously at the maximum licensed power) show that, in order to be exposed to RF levels near the FCC's guidelines, an individual would essentially have to remain in the main transmitting beam and within a few feet of the antenna for several minutes or longer. Thus, the possibility that a member of the general public could be exposed to RF levels in excess of the FCC guidelines is extremely remote.

When cellular and PCS antennas are mounted on rooftops, RF emissions could exceed higher than desirable guideline levels on the rooftop itself, even though rooftop antennas usually operate at lower power levels than free-standing power antennas. Such levels might become an issue for maintenance or other personnel working on the rooftop. Exposures exceeding the guidelines levels, however, are only likely to be encountered very close to, and directly in front of, the antennas. In such cases, precautions such as time limits can avoid exposure in excess of the guidelines. Individuals living or working within the building are not at risk.

- An electronic toolkit is available which includes talking points, sample speeches, new releases, newsletter copy, event suggestions, flyers, stickers, and doorknob hanger templates, and more.

You can play an important leadership role in encouraging your community to mail back their forms. Most 2010 Census questionnaires are delivered from March 15-17, 2010. From the time the forms are delivered until the closing of the mail campaign at the end of April, you have the opportunity to remind your area residents of the importance of mailing back their census forms. We believe that you can encourage participation through speeches, special events, and challenges. The stakes are high; an accurate count of the local population helps to ensure that your community receives its fair share of federal funding. This funding includes resources for services, such as health care, education, and roads. **Your constituents must complete and mail back their census forms between March 15, 2010 and April 15, 2010. The good news is that the 2010 Census questionnaire is one of the shortest in history-just 10 questions that only take about 10 minutes to complete.** We hope we can count on you to encourage participation in the 2010 Census. ## CRIME SOLVERS OF FAIRFAX COUNTY

Your Board of Directors was contacted recently by CRIME SOLVERS of Fairfax County and asked to consider in aiding that organization in their efforts to fight crime in our immediate neighborhoods. The Board opted to make a cash contribution to help in the fight against crime.

CRIME SOLVERS is a board of volunteers who raise money to pay tips to confidential informants who provide information contributing to solving crimes or apprehension of fugitives. FAIRFAX COUNTY CRIME SOLVERS has actively worked with the Fairfax County Police Department and Washington, D. C. - area news media since their beginnings in 1979. During that time they have paid out over \$223,000 in rewards for tips leading to the resolution of more than 1,700 crimes and the arrest of more than 800 criminals, including the apprehension of at least 200 fugitives.

## OVERALL CRIME DROPS IN 2009

Fairfax County ended 2009 with an overall drop of nearly 5 percent in index crimes compared with 2008. Index crimes, reported monthly to federal authorities, include murder, rape, robbery, aggravated assault, burglary, larceny and motor vehicle theft.

Violent crimes (murder, rape, robbery and aggravated assault) decreased by 14.6 percent; property crimes (burglary, larceny and motor vehicle theft) decreased by 4.5 percent.

“I’m pleased to see the drop in overall crime and especially the nearly 15 percent decline in violent crime,” said Colonel Dave Rohrer, Chief of the Fairfax County Police Department.

“One of our key anti-crime strategies is our focus on repeat offenders. Historically, a small percentage of offenders commit a high percentage of crimes, and we have made it a priority to focus on them.”

## SCHOOL NEWS

February was a great month at Crestwood. We just passed the mid-year point for learning and instruction for the 2009-2010 school year. Teachers have assessed learning for students and report cards have gone home. We still continue to ask parents to sit down with their child (children) and review their academic and personal goals for the year. Make sure they are completing homework every day. Talk to them about school and what they are learning. Discuss goals that will help them be successful. A very important goal is to make sure they do homework every night. Continue to review the Thursday folder and the calendar that we include in the monthly newsletter.

**Cold Weather Safety:** Fairfax County Public Schools Office of Safety and Security publishes a document called “Cold Weather Safety”. In this document the question is answered...”How cold is too cold to allow students to play outdoors?” We consider several factors when making this decision. We look at the wind chill factor, whether the ground is frozen, if the sun is shining, if the children are dressed appropriately, the length of time to be spent outside, and of course the temperature plays a factor. If the temperature is less than 32 degrees or the wind chill factor causes the temperature to feel like it is less than 32 degrees, we cancel outside recess. On the days of no outside recess, the teachers are encouraged to have indoor recess for students. Children should always wear hats, gloves, coats and long pants because they may still walk outside to get around the school on a daily basis. We count on parents to help us make sure that children are properly dressed for the weather. To stay informed regarding weather conditions, you may go to WeatherNet4 (<http://www.nbc4.com>), the National Weather Service ([www.nws.noaa.gov/](http://www.nws.noaa.gov/)) and the Weather Channel ([www.weather.com](http://www.weather.com) .)

With the recent bout of snow storms, we will need to make up a number of days that have been missed due to snow and ice. Crestwood, as well as all Fairfax County Schools will be checking the calendar to make sure that we get the maximum instruction and learning that the school year allows. Always remember, however, spring is just around the corner!

In spite of the snow, there are no major delays in the progress of the construction. I spoke to a county contact person and the most they anticipate is perhaps two days! A certain number of inclement weather days for February are already built into the contract. Work inside is going very well. There will be mechanical and electrical inspections the week of Feb. 15. Once those are done and we get those approvals, the remainder of the ceiling tiles will be installed. Most of the painting is done, and about 75% of the lighting is installed. Carpet and doors will follow soon afterward.

All of us at Richard Byrd were very curious about measures being taken to prevent leaks and roof damage during heavy snows. Although we seldom get this much snow, it does happen every once and a while. According to my contact, new buildings are designed for the snow load, and there have been no major issues recently at the site. County staff has been out to the site a couple of times since the two storms, specifically to look for things like that.

The roof of the tower is complete. The original windows that were shipped were the wrong size but the correct ones have arrived and been installed.

Another interesting detail about the new Richard Byrd: the shape of the roof is designed to look like an open book.

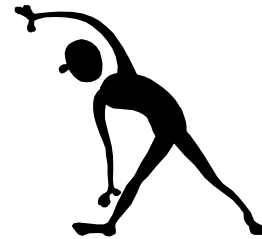
## METRO RUN & WALK ESTABLISHES FOOT-RACE FOR SPRINGFIELD DAYS

## A MESSAGE FROM SUPERVISOR JEFF MCKAY

Last year, our county budget was a wake up call to many of us who saw Fairfax as a land of plenty with quality of life for all. Slowly, we came to understand that we, too, were subject to the strong financial headwinds battering the national and state economies.

The county executive's proposed budget for the fiscal year that begins on July 1 reflects our new reality—one that is likely to continue for some time. Between the proposed budget's release and its adoption on April 27, my colleagues and I will be listening to constituents and working to fine tune the budget to align it as closely as possible with citizen priorities and economic reality. It will be a challenge to maintain our quality of life and our school system while reducing services and turning our backs on programs that might be wonderful but unaffordable. I will be participating in these budget deliberations believing that there are some government responsibilities that are not negotiable. Public safety and basic human services are more important than ever during this economic downturn.

At first read, this budget makes the best of a difficult situation. I am pleased that it recognizes the importance of zoning enforcement to our neighborhoods. Bringing together staff from different agencies into a centralized department of code enforcement (including the Strike Team) will let us respond to enforcement issues more quickly, efficiently, and cost-effectively. The budget also recognizes that we cannot use homeowners as a bottomless piggy bank for programs that we cannot afford. While the county executive's proposed budget has a property tax rate of \$1.09, because of declining property values, the

average homeowner's bill will be \$48 less than last year's. This budget also recognizes the need to find revenue sources other than homeowners and I note that my suggestion last year to reinstitute the vehicle registration fee has been included. The \$33 fee is estimated to raise \$27 million a year

Schools are the Board of Supervisors' priority and that's reflected in this budget with almost 54 percent of the General Fund. It may be possible to increase the school transfer but it's too early to make that call as we wait for more information about the impact of the state budget on K-12.

Right now, I am concerned by the proposed elimination of middle school SROs (school resource officers)—these police officers have made impressive inroads into eliminating gang activity in our schools. Eliminating them would cost us much more in the long run.

Our challenge is to find new ways of doing things: better and more efficient ways to stretch our revenue dollars, more partnerships with non-profits and the private sector, and diversified revenue sources to take the pressure off our homeowners.
